



# Approved Tree and Hedge Materials List

The following is a list of approved trees and hedge materials permissible in landscaping within unincorporated Hillsborough County. Any proposal to deviate from these lists must be approved by the staff of the Development Services Department's Natural Resources Team.

## Trees

The trees listed below have been approved for one or more of the following uses as indicated.

**Shade Trees:** The following list of trees represent acceptable Shade Tree species to satisfy Section 6.06.03.A, of the Land Development Code. These trees generally obtain a mature height of 25 – 70 feet.

**Ornamental Trees:** The following list of trees represent acceptable Ornamental Tree species. These trees generally obtain a mature height of 15 – 25 feet.

**Street Trees:** The following list of trees and palms represent acceptable Street Tree species to satisfy Section 6.06.05, of the Land Development Code.

**Shade Tree Island:** The tree is acceptable for planting in shade tree islands.

**Planted Under Power Lines:** The tree poses minimal risk due to height and is acceptable for planting under above-ground power lines.

**Screening for Incompatible Uses:** The tree represent acceptable Incompatible Land Use Screening Tree species to satisfy Section 6.06.06, of the Land Development Code.

**Characteristics:** N-Native, F- Flowering, E- Evergreen, D- Deciduous, P- Must be planted in clusters of 3 to credit as one landscape tree.

<sup>1</sup>**Note:** Unless otherwise indicated, when replacing a street tree with a palm species, 2 palms must be planted for every street tree removed.

<sup>2</sup>**Note:** In a landscape environment, 3 palms must be planted in a cluster to credit as one tree unless otherwise indicated

<sup>3</sup>**Note:** Foxtail Palms are permitted for use as Ornamental and Street Trees in a designated area within Hillsborough County. This highlighted area of map details the area in which the use of Foxtail Palms is permissible.

<sup>4</sup>**Note:** Only allowed if overhead power lines are present.

<sup>5</sup>**Note:** Distance from the tree to curb or sidewalk must be a minimum 8' and minimum of 15' from utilities/hardscape

<sup>6</sup>**Note:** Not acceptable for planting in internal or terminal landscape islands elements
